
School Psychologist Services Contract 2014-2015

This is a contract between Taylor's Crossing Public Charter School (TCPCS) and Bruce Blake, School Psychologist. This contract is entered into on the 14th day of May, 2014.


Bruce Blake agrees to serve as a School Psychologist for the 2014-2015 school year by providing Psychological services, testing, reporting and consultation regarding students referred for special education testing by TCPCS. Specifically Bruce Blake agrees to provide testing services and preparation of supporting reports at the school on an as needed basis, (estimated 10 students at 4hrs per student). Bruce Blake agrees to use Denise Van Stone, Director of Special Services and Special Education Teacher for TCPCS, as the contact person for all matters pertaining to this contract.

TCPCS agrees to pay Bruce Blake by the last day of the month when itemized bills are submitted by the 5th of the month. TCPCS agrees to pay Bruce Blake at a rate of \$75.00 per hour for services rendered. Bruce Blake shall keep complete and accurate records of time spent on services rendered to TCPCS and shall make such records available for inspection by TCPCS upon request and at reasonable business hours. Bruce Blake agrees to provide Medicaid billing sheets on all eligible students for billing purposes.

This contract is subject to renegotiation at any time and either party is free to terminate it with a thirty day notice. Signatures of appropriate parties indicate agreement to the terms of this contract.


Speech/Language Therapy Services Contract

This is a contract between Taylor's Crossing Public Charter School (TCPCS) and Gail Kisling, Speech Language Pathologist. This contract is entered into on the 14th day of May, 2014.


Gail Kisling agrees to serve as a Speech/Language Pathologist for the 2014-2015 school year by providing speech/language therapy, testing, reporting and consultation regarding students referred by TCPCS. Specifically Gail Kisling agrees to provide weekly (3-5 times per month) services at the school and supervise a trained paraprofessional to provide supplementary services. Gail Kisling agrees to use Denise McClure, Director of Special Services and Special Education Teacher for TCPCS, as the contact person for all matters pertaining to this contract.

TCPCS agrees to pay Gail Kisling by the last day of the month when itemized bills are submitted by the 5th of the month. TCPCS agrees to pay Gail Kisling at a rate of \$60.00 per hour for services rendered. Gail Kisling shall keep complete and accurate records of time spent on services rendered to TCPCS and shall make such records available for inspection by TCPCS upon request and at reasonable business hours. Gail Kisling agrees to provide Medicaid billing sheets on all eligible students for billing purposes, as needed.

This contract is subject to renegotiation at any time and either party is free to terminate it with a thirty day notice. Signatures of appropriate parties indicate agreement to the terms of this contract.
